**RENTAL CONTRACT FOR EXHIBIT SPACE**

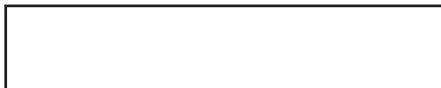

Hereinafter referred to as "Exhibitor" the right to renting during the Exhibition for the dates of January 22, 23 & 24, 2010 space number(s) \_\_\_\_\_, as shown on the official floor plan, which consists of \_\_\_\_\_ feet on the aisle and \_\_\_\_\_ feet deep. This space is to be used to exhibit the following \_\_\_\_\_ and shall be subject to the following conditions:

1. The Exhibitor agrees to pay 50% of said rental on or before \_\_\_\_\_ and the remaining 50% by December 4, 2009.
2. Set up for the exhibits must be complete and ready to open to the public by 3:00PM on Friday, January 22, 2010. Exhibitor shall not begin to dismantle or do any packing prior to the official closing time of the show, 5:00PM, January 24, 2010. Removal of entire exhibit and clean up of rental space shall be completed by 9:00PM January 24, 2010. If removal and cleaning is not completed by that time, the Show Manager shall have the right to remove and store the property not removed, and clean up the rental space, all at the expense of the Exhibitor.
3. No unattended exhibits are permitted. Exhibitor is to have competent personnel at his/her exhibit during all public hours.
4. All exhibit activities must be confined to Exhibitors booth space.
5. Exhibitor agrees not to bring onto the premises any material, substance, equipment or object which, in the judgement of Show Management, is likely to endanger the life of, or cause bodily harm to any person on the premises, or which is likely to constitute a hazard to property thereon.
6. Insurance, if desired by the Exhibitor, must be obtained by Exhibitor at their own expense. NOSS and Showmasters, Inc. assumes no risk, by signing this agreement, the Exhibitor expressly releases NOSS and Showmasters, Inc. of and from any and all liability for any damage, injury or loss to any person or property, which may arise from the rental and use of said space by the Exhibitor, and the Exhibitor agrees to hold and save harmless NOSS and Showmasters, Inc. of any and all loss, injury, or damage by reason thereof. NOSS and Showmasters, Inc. assumes no responsibility whatsoever for any property placed in the exposition building and NOSS and Showmasters, Inc. is hereby released and discharged from any and all liability from any loss, injury or damage to persons or property.
7. Employee passes will be issued on Thursday and/or Friday, January 21 - 22, 2010. Each 10' x 10' space shall be entitled to four (4) employee passes, and larger spaces shall be entitled to six (6) employees passes. Booth space may not be resold to anyone without permission from Show Management.
8. NOSS and Showmasters, Inc. will not be liable for refunds or any other liabilities whatsoever for the failure to fulfill this contract due to any occurrence beyond the control of NOSS and Showmasters, Inc.
9. Disputes arising from any cause whatsoever, among Exhibitors, shall be adjusted by Show Management whose decision will be final. The Show Management further reserves the right to discontinue any exhibit which may be conducted in violation of the conditions, rules and regulations governing the show. There will be no refund of rental space.
10. The conditions and regulations printed herein are made a part of hereof and incorporated herein and the Exhibitor agrees to be bound by each and every one of them and the Show Management shall have full powers of interpretation, amendment and enforcement of all said conditions, rules and regulations.
11. The Exhibitor agrees to abide by all fire regulations and/or decisions of the representative of the local fire department. All boats and vehicles with built-in gas tanks must have fill caps taped shut.
12. The Exhibitor shall be solely responsible for the collection of sales tax for any goods sold during the Exhibition and no modifications shall be valid unless written upon or attached hereto and same are approved by the Show Management.
13. The rental contract constitutes the entire contract between NOSS and Showmasters, Inc. and the Exhibitor and no modifications shall be valid unless written upon or attached hereto and same approved by Show Management.
14. Manufacturers and manufacturers representatives if selling their products to the public MUST comply to the dealers retail price in this area.
